2020 TSCA State Championship -

Cesar made a presentation regarding the Covid-19 virus and implications to the 2020 Texas State Shoot. California, New York, Florida and Washington state have been the hardest hit. Person to person contact is causing the spread. To date, San Antonio still has a low incidence with only 5 reported cases. Still in exponential curve phase, still rising with more and more being reported each day. High mortality expected in older, infirmed individual. Situation is very fluid and avoiding contact with others is the best way to prevent the spread. San Antonio has not restricted gathering as of this date.

Dr. Nassir (in a conversation with D Vines) offered that his recommendation would be to reschedule. Noted that a single trapper who tested positive filling out scorecards would expose all those passing thru his station. Also noted the demographic of TSCA shooters and advanced age of many of the shooters.

Danny suggested that we postpone the Texas State Championship to July 8-12, just prior to the world FITASC.

Cesar noted the "stay at home" and social measures are currently expected to last about 3 weeks. He urged that due to the unknown aspects of this disease, we remain fluid on the dates as the time periods could last to 3 months.

Dwight noted that other shoots are being canceled daily and are being re-scheduled, filling up the calendar. Suggested that we lock up the date that is being presented. Sara suggested that the Board stay diligent in watching the virus and the potential to have to re-schedule past July.

All registrants for the State shoot will be moved to the same dates and times in the July timeframe. Refunds on deposits to follow NSC standards.

Small Gauge Challenge -

Dwight reported that the Texas State Shoot, as scheduled for April, was to be the first in the Sub-Gauge Challenge series with other shoots following closely thereafter. Given the difficulty in agreeing to dates with the hosting clubs and the likelihood of further shoot cancellations throughout the state and throughout the US, Dwight recommended that we cancel the Texas State Sub-gauge Challenge for 2020. Sub-gauge Challenge to resume in 2021.

Texas State Championship Merchandise -

Agreement has been reached with Apparel on Target regarding merchandise to be printed on-site for the shoot. Also, agreement has been reached to split profits with NSC.

New website address for Apparel on Target will be distributed to the Board for review of proposed merchandise when website is functional again.

4H/FFA Discussion -

Ron expressed that he felt that the re-scheduling of the State Shoot would help in attendance due to shooters not having to miss school in order to participate. Amy Crow has reported that she has had several inquiries about the shoot and that many were waiting to see if/when the shoot would be scheduled. With schools being out there is no way, currently, to communicate with the schools/shooter.

TSCA Board of Directors Election -

Sara reported that she has the Bio's for existing incumbent Board members and there are three others who have provided applications. Jommy Holder, Patrick Welborne and Paul Montealegre. It was reported that Dominic Gross has submitted an application, but to date it has not been received by either Charlie or Sara. His application will be accepted if received immediately.

Nominations were closed on 2/26th and are not being re-opened. Ballots will be done on the TX Clays website. Ballot dates to be published to the board in the next few days.

Texas Clubs Benefit Shoots -

Gary submitted a copy of the Shoot Outline for discussion. He is focused on pushing this shoot thru and is looking for another co-chair. Charlie volunteered to assist.

Conversations are continuing with Krieghoff regarding their sponsorship. The proposed shoot has been discussed with several clubs and is thought to be headed to a 2-day shoot. Date looks to be early October, prior to the Nationals. KI would like a rotating trophy and would like to get the three distributors located in Texas to provide some sponsorship. KI is also investigating potential ammunition sponsors.
